The Prevocational Medical Assurance Services (PMAS) is pleased to announce the Northern Territory Clinical Educator of the Year Award 2023. PMAS in conjunction with the Confederation of Postgraduate Medical Councils (CPMEC) is offering this award which recognises the contribution of a clinical educator working in the Northern Territory.

PMAS would firstly like to call for nominations and select a territory winner who will then be recognised as our nominee for the CPMEC National Clinical Educator of the Year Award.

The Territory Clinical Educator of the Year Award winner will be announced later in 2023.

All state/territory winners will be recognised and the national winner will be announced at the 27th Medical Education and Training Forum to be held in Perth, Western Australia on the 12th – 15th of November 2023.

****Nominations for this award can only be made by junior doctors.**

The recipient of this Award will be a clinical educator who fulfils the principal criteria which can be demonstrated by at least two additional criteria as listed below: *(please include any contributions during the COVID-19 measures in this submission)*

Principal Criteria

1. Made a significant contribution to the teaching of junior doctors in the years PGY1 and PGY2

Additional Criteria

2. Demonstrated evidence of developing innovative programs and approaches for the education of junior doctors; **and/or**
3. Made a significant contribution to mentoring and the provision of career advice to junior doctors; **and/or**
4. Made a significant contribution to promoting and advocating the well-being of junior doctors; **and/or**
5. Evidence of advocating for junior doctor education and training in the workplace and beyond, which could include contributions to the PMC or any organisation involved in the education and training of junior doctors; **and/or**
6. Evidence of improving education opportunities in rural health (particularly in the NT); **and/or**
7. Evidence of improving access to quality healthcare for Aboriginal communities; **and/or**
8. Contribution to medical research within Australia (particularly in the NT); **and/or**
9. Demonstrates commitment to the NT; **and/or**
10. Any other relevant information you wish to include.

A **clinical educator** is defined as a person who is involved in the teaching, supervision, mentoring, guidance and support of junior doctors in years PGY1 and PGY2, and whose direct contributions has created a positive learning environment for them. The nominee could be a clinician who is an educational or term supervisor, a medical education officer, or any other person who has made a very significant contribution to JMO education and training through the work of a PMC, or any other organisation involved in the education and training of junior doctors.
