## Feedback on AMC Prevocational Trainee Guide

The AMC via the CPMEC AJMOC asked for feedback on their new guide for medical students and junior doctors in understanding the new PGY1/PGY2 Prevocational Training Framework. This feedback was on the structure and content of the guide rather than the framework itself, and was submitted on the 7th of February 2023.

## **Proposal for Trainee Feedback in Accreditation Processes**

The NT JMOF has been discussing the benefit of direct JMO Feedback to survey teams in accreditation of health services. The challenge of individual surveys of JMOs is that it relies on

engagement which is often poor, and it also suffers from both sample and recency bias. We'd like to propose a process by which JMO Societies submit a report as part of the accreditation process, similar to the AMC's procedure for accreditation of medical schools. We are working on the finer details of this proposal and consulting with other state JMO Forums to learn about their processes. Work on this proposal is ongoing and we will aim to have it finalised following the February/March meeting.

# **Collaboration with Hospital-based JMO Societies**

To best inform representation and advocacy, we would like to partner with local Representative JMO Societies to get feedback. This relationship will be bi-directional in that any advocacy concerns we identify that are best dealt with at a local level. The Chair of RDH DTAG David has been involved, and I have attended on behalf of ASH RMO Soc. We look forward to seeing this partnership grow over the year.
