Outcomes of meetings:

The April NTJMOF meeting of 2026 mainly revolved around introductions. There were general introductions for all members, followed by a brief introduction to the function of the NTJMOF.

Afterwards, a review of CPMEC priorities was conducted to give direction to our focus areas as a nation – education, IMG support, and wellbeing. Updates from central and top end were then given by the local networks' respective chairs.

The main outcomes of later meetings will now be discussed.

The items which came out of the meetings included the NT internship webinar: conducted 8th May, 2026. Many students attended however only about half of those who registered attended. We have seen a great impact for recruitment from this webinar, with every intern position filled for the NT in 2026 so far.

We also discussed the relocation guideline changes with CMOs office. For context: there is no current standardised guidelines on relocation costs across the NT for new-starting doctors. We proposed to the CMO's office that this should be standardised procedure in 2025 and that the NTJMOF would like to be involved with ongoing changes to the procedure. We have since submitted feedback twice and have been involved in ongoing changes to the guideline in tandem with the CMO's office. We are awaiting an ongoing update.

Further business included ongoing concerns of poor communication of AMC framework for internship being given by MEUs of both top end and central NT. This was followed up with NTPMAS.

Additionally, the Top End Trainee group gave feedback on accreditation recommendations, the first time this has occurred. This has been forwarded to NTPMAS.

Another item of discussion was aligning Northern Territory applications for junior doctors. Currently JMOs apply to 2 different portals (Top End, Central) and then receive offers at competing times. A general consensus was reached that JMOs would like a centralised application and the potential to work between sites. NTJMOF will action this to a letter of support raised to DMS.

Unanimously, there appear to be ongoing difficulties with interpreting payslips and accessing overtime pay.
